## President's Remarks

The month of July has been very busy for the three Leagues representing Summit County. Quick action was taken to make our voice heard on the upcoming changes in voting.

The Summit County Board of Elections has been reviewing issues of early voting location and precinct reductions for Election Day. The League of Women Voters of the Akron Area, along with Tallmadge and Hudson Leagues and LWV Ohio, issued a statement and sent several representatives to two meetings held by the BOE.

In both meetings the Board of Elections members could not agree on any of the issues in regards to voting, with votes split along partisan lines. This lack of cooperation puts all local voting decisions in the hands of the Secretary of State's Office.

The three Summit County Leagues have been working with LWVO, which has met with the Secretary of State's Office in this matter. LWVO still has orders from the federal court to review actions of the Secretary of State's Office as a result of their successful 2005 law suit where the Secretary of State's Office was found to have failed to protect the fundamental rights of Ohio voters to cast a meaningful ballot, as re-

quired by the Equal Protection and Due Process Clauses of the Fourteenth Amendment to the United States Constitution. The law suit calls for monitoring by state and local leagues through 2015.

We are the only county in the state of Ohio making major changes to voting precincts before the presidential election. These delays in decision making will make our voter education efforts more challenging by creating a tighter time frame to get information to the public.

Changes in the precincts and polling locations are going to be a challenge during a busy Presidential Election Year. Once the changes are finalized

we will make every effort to assist the Board of Election in getting this information out to the public.

Thank you to all of the LWVAA board members who attended the meetings and provided input on this issue, especially Sara Gibbs, Public Relations Chair, who worked late into the night and early the day of the first meeting to get our statement written and approved by LWVO and Tallmadge and Hudson Leagues.

*Meetings are held the first Thursday of each month at 5:30 pm at Christ United Methodist Church on Mineola Ave. in Akron and are open to the public. The next board meeting will be August 2, 2012.*

At the June 28 meeting the Board:

- Reviewed League's non-partisan policy.
- Encouraged members to attend a board or committee meeting and learn more about what LWV does. Positions are available for a 1 year term as a committee or board member.
- Approved the revised budget proposal for 2012-2013, subject to final approval of members present at the annual picnic in August.

- Received permission from Dave Lieberth of the City of Akron to have a Voter's Registration table at Lock 3 Summer concerts and other events.
- Discussed possibilities for upcoming candidates' forums; importance of educating voters about precinct changes; emphasized the importance of vigilance about voter access and voter protection from disenfranchisement and the League's role in those efforts.
- Approved purchase of a portable PA speaker system with 4 handheld microphones, with funds available from the Education Fund.
- Learned a League representative was asked for an interview about the history of Woman Suffrage for a PBS special.
- Discussed The Voters First Ohio re-

## Summit County Leagues Chastise Board of Elections

*The following joint statement of the Summit County Leagues, Akron Area, Hudson, and Tallmadge, was presented to the Summit County Board of Elections meeting on July 10, 2012.*

The League of Women Voters believes that voting is a fundamental citizen's right that must be guaranteed. Accessibility to the election process is integral to ensuring a representative government and the right of every citizen to vote.

Impeding accessibility to vote by creating barriers such as limiting space and parking for the early and absentee voting location, thus subsequently causing long lines and physical discomfort, subjects the voting process to undue stress. This violates the Ohio County Board Election Official Manual dated December 2010, Chapter 5, which states: "provide for the convenience of the voters, and the proper conduct of elections arranging for a sufficient number of voting devices to accommodate the number of electorates, taking

into consideration the size and location of each selected polling place, available ample parking for the handicapped and other accessibilities to the polling locations".

Off-site early voting is much more imperative today since the number of precincts has been condensed to fewer locations to vote. A building location of ample size and parking is of the utmost importance to facilitate this change.

The Summit County BOE should be able to work together and provide a pre-election plan to minimize such problems. Failing to put partisan politics aside and work together to achieve the duties that they have been appointed to carry out has resulted in unnecessary delays in educating the public as to when and where to vote in Summit County.

To rely on the Secretary of State to decide, because of the Board's inability to come to consensus on the issue of a location speaks volumes: that this Board is not

able to serve the voting needs of the citizens of Summit County that they were appointed to serve.

The League of Women Voters of Ohio Election System Lawsuit Settlement was to improve and make significant changes to Ohio's Electoral Process. We urge all Summit County Citizens to call upon this Board to set aside political biases and do what is right for the citizens of Summit County.

# Member Spotlight on.....Rhonda Gail Davis

### When did you join the League?

I joined for awhile in the 1990's, then I just got too busy and dropped out for awhile. When my schedule got a little less hectic, I looked at all the organizations I had belonged to and made a very selective choice to return to League, because I felt it was one organization that really made a difference. I think it was around 2007 that I rejoined.

### Why did you join LWVA? And why have you stayed in League?

I was really impressed by a League candidate night. I was working for a judicial candidate, and I thought, "This is so systematic and organized and so well done! I want to know more about this organization!" Everyone was treated with respect, everyone had the same amount of time, and time to connect with voters. Around that same time I got to know the Voters Guide through Tina Merlitti, and I thought it was such a good source of fair and impartial information about candidates and issues. I still distribute it to clients. I have stayed in League because I

really value what we do.

### What positions, if any, have you held within the League?

I have been a general board member, have served as a parliamentarian for some meetings, and have chaired the by-laws committee on two occasions.

### What do you find most rewarding about being a League member?

I think it's knowing that there are lots of women working to make things more fair. There are women of all ages working toward that same goal, and that's something you don't find a lot. It's sort of like an adult civics class on an ongoing basis, and it really increases your civic awareness and sense of responsibility.

### What do you think is the biggest issue voters face?

Probably cutting through all the disinformation that's out there. 30-second and 60-second ads don't provide information on candidates and issues. Voter disenfranchisement is a big issue too, and I always

volunteer with Election Protection because of that, but I think the disinformation situation is more critical.



### Are you involved in any other community organizations?

I serve on the Akron Bar Association Grievance and Disciplinary Committee. I also volunteer with the Medina Community Band — my husband plays the flute with them. I volunteer with families for Stark County DD [Developmental Disabilities]. I am also involved in various lawyer organizations both local and national.

### What interests do you have outside of the League?

I golf — very badly, but I enjoy it. I'm also a frustrated beginning guitar player with New Horizons Community Band.
