President's Remarks by Tina Merlitti

VOTE EARLY! I know you have heard this before but this year more than any other it could save you much time and many headaches. We have never before seen so many changes in voting districts, precincts, and polling locations all at one time—and during a presidential election that will no doubt have a very large turnout. This promises big headaches to come!

Your congressional districts and county council districts have changed. You may not see the names on the ballot that you have voted for in past elections, and you may see names you haven't seen before.

Your precinct has likely changed. The number of precincts have been reduced so

there will be more people going to fewer tables of workers. The polling locations have changed in many cases. There are fewer locations with more people. Some locations have as many as 5,000 register voters assigned to them.

Even if you haven't done so in the past, please consider voting by mail. Voting in the comfort of your own home allows you the time to use our Voters Guide, do your own research or phone a friend when you have questions about your ballot.

An absentee ballot request form can be obtained by calling the Board of Elections at 330-643-8626 or you can download a form at www.summitcountyboe.com. If you do vote by mail, your ballot must be postmarked by Election

Day, November 6th.

Early Voting in person can be done at the Board of Elections starting October 2nd. The Board of Elections is located at 470 Grant Street in Akron. Parking at the Board of Elections is limited, but you may park at the McDonald's headquarters at 801 Wolf Ledges Parkway.

Our League of Women Voters Voters' Guide is available on line at www.lwvaa.org or at your local library, Acme store or various other locations. We take great pride in providing this non-partisan information to you to help you be more informed about the issues and candidates so you can vote the entire ballot. I encourage you to use this guide as you vote this year.

You can use our guide to vote

from home or bring it to the polls with you if you vote early or on Election Day so that you can refer to it during voting.

In addition, you can attend our judicial candidates' night on Thursday, October 23. It always seems like the judicial races are the most difficult to get information about, so this is your chance!

Candidates for Summit County Common Pleas, Probate Court, and 9th District Court of Appeals will be in attendance at a forum at the Jewish Community Center, 750 White Pond Drive, Akron at 7:00 PM on Thursday, October 23. Make plans to attend!

At the September 6 meeting the Board heard the following reports:

Summit County Board of Elections:

- President Tina Merlitti said Leagues in Summit County are observing meetings and encouraging the board to resolve disputes re early voting
- LWVOhio has met with Secretary of State's Office re Summit County BOE
- Early voting will be held at the Board of Elections, with overflow parking at the McDonald's headquarters next door.

Voter Registration:

Did You Know — Sojourner Truth

Sojourner Truth (1797? – 1883) was an abolitionist, women's rights activist and former slave. She is perhaps best remembered for her "Ain't I a Woman?" speech which she gave right here in Akron, Ohio in 1851.

Sojourner Truth was not born a slave in the South. She was born a slave in Ulster County, New York. She was later freed and spent much of her life working as a live-in household worker.

She was a religious person and believed that the Holy Spirit told her to change her name from Isabella to Sojourner Truth (Sojourner means "Itinerant Preacher"). She traveled to Brooklyn, Long Island and joined a commune in Northampton, Mass. It was during these journeys that

she became an abolitionist and women's rights activist.

Her parents were perpetually depressed. They were also enslaved and had lost about 12 children to the slave trade. In Sojourner Truth's narrative she tells us that her parents would sit around the fire and tell her about her siblings who had been sold away. Her mother would look up at the stars and say, "See those stars? Those stars are shining on your brothers and sisters. We don't know where they are, but we're all under the same heaven."

After the Civil War Sojourner Truth worked in Washington D.C. with the freed people and refugees. Because there was little work in the East, she encouraged people to head West and was de-

lighted with the exodus to Kansas in 1879.

She met with three different presidents and there was a picture painted of her meeting with Abraham Lincoln.



Sojourner Truth was ill for the last three years of her life. She died in Battle Creek in 1883 and is buried in Oak Hill Cemetery.

LWV Ohio's Stance on State Issues 1 & 2

In taking a stance on questions pursuant to the Ohio Constitution and proposed constitutional amendments, the League of Women Voters of Ohio (LWVO) considers the public policy positions which the League of Women Voters of the United States (LWVUS) and LWVO have adopted after careful study and member consensus.

Issue 1: Question Presented Pursuant to Article XVI, Section 3 of The Constitution of The State of Ohio: Should there be a convention to revise, alter, or amend the Ohio Constitution: NEUTRAL.

Under the Ohio Constitution, every 20 years voters are asked: "Shall there be a convention to revise, alter, or amend the constitution?" If voters decide in favor of the constitutional convention, the General Assembly will make provisions concern-

ing electing delegates for a convention to revise, amend or change the Ohio Constitution.

Stance: LWVO's position on the Ohio Constitution (adopted 1968) calls for a clearly stated body of fundamental principles that should provide for the flexible operation of government and be logically organized and internally consistent; the relevant LWVUS position calls for the right of citizen participation, Given compelling rationales both for and against holding a constitutional convention at this time, LWVO takes a neutral stance on Issue 1.

Issue 2: Proposed Constitutional Amendment to Create a State-Funded Commission to Draw Legislative And Congressional Districts: SUPPORT.

This constitutional amendment proposed by initiative petition seeks to change the

way legislative and congressional districts are drawn in Ohio. It would require the creation of an independent citizens commission with the responsibility to draw district lines in proceedings open to the public. The commission's decisions regarding district lines would be required to be based on objective, good-government criteria. If Issue 2 is approved, new districts would be drawn for the 2014 election, and following every census thereafter.

Stance: LWVO's position on redistricting (adopted 1980) calls for an impartial districting process with opportunity for citizen participation. Accordingly, LWVO supports Issue 2.

Observer Corps Volunteers Needed!



If you have been following the partisan shenanigans going on at the Summit County Board of Elections this fall, you know how important it is to keep an eye on our local government. That is why the League of Women Voters Observer Corps is such an important part of what we do.

We know from experience that elected officials take notice when a League member shows up to watch the proceedings. Sometimes the meetings are confusing and a lot of the business gets done in committee. Don't let that deter you.

There are 3 things to remember if you decide to attend public meetings as a member of the Observer Corps:

1. Wear a League button identifying you as a League member. (ask me to get you one if you don't own one)
2. Do not offer comments of any sort since you are representing the League
3. If you are so inclined, submit a BRIEF synopsis, preferably by email, to me (jmgd3@neo.rr.com) of proceedings but this is secondary to attending the public meeting. This is NOT required.

and drop me a line if you participated as an Observer. I will forward your communications to our Newsletter Maven, Erica Greer. She will also pass it along to the Webmeister, Bruce Greer. Together, they are known as the Great Communicators.

Victoria Woodhull, First Woman Candidate for U. S. President

Although one of the most famous women of her day, few people today remember the first woman candidate for President of the United States, Victoria Woodhull. She and her running mate, Frederick Douglass, the first black candidate for Vice President, were nominated by the Equal Rights Party in 1872.

Victoria Woodhull was a leader in the women's suffrage movement, and a long-time activist for women's rights and labor reform. Many years ahead of her time, she advocated for an eight-hour day, a graduated income tax, profit sharing, and social welfare programs, besides advocating for women's political and social equality.

She was also an advocate for free love, by which she meant the freedom to marry, divorce, and bear children without government interference. In her day,

women were often trapped in loveless or abusive marriages without options. A divorce was difficult to come by and of such a scandalous nature that a divorced woman was stigmatized and socially ostracized.

With her sister, Tennie Claflin, Victoria Woodhull founded the first American brokerage firm operated by women. She and her sister also published a weekly newspaper, where she was able to express her radical views on topics ranging from sex education and free love to legalizing and licensing prostitution to vegetarianism.

It was her article about the revered minister, Henry Ward Beecher, however, which got her into the most trouble.

Henry Ward Beecher, the brother of Harriet Beecher Stowe, author of *Uncle*

Tom's Cabin, had preached against her ideas on free love, but at the same time was conducting an affair with a married woman. She publicized the affair in her newspaper to illustrate the sexual hypocrisy and double standards of the day.



She was arrested and jailed on Election Day, 1872, for "publishing an obscene newspaper" because of her article about Beecher.

In the end, her candidacy yielded no electoral votes, and the popular votes cast for her were not counted because her candidacy was viewed as illegitimate because she was a woman.
