The League of Women Voters of the Akron Area is not now, never has been, and never will be partisan. But we are going to be better proof readers in the future - that I guarantee.

Thank you to our many members who reached out with messages of support, especially Janice Jacobs and the Ed Fund Committee, who fund the *Voters' Guide*. This year's *Voters' Guide* was our first in collaboration with Hudson and Tallmadge and their communities were also adversely affected by Akron's errors. Tammy Shomo, Tallmadge president, and Kathy Cybulski, Hudson president, worked to pick up *Guides* and communicate our joint message of apology to their members and the

public. The Board and I apologize to each and every one of you and want you to know that we will work diligently to be sure this debacle never repeats. However, I cannot stress enough that there was *absolutely nothing partisan, targeted, or intentional* about any of the problems we had in the publication and dissemination of the *Voter's Guide* for 2014 general election.

And what a sad election it was. Voter turn out under 40%. For Millennials, the turn out is estimated at 12%. Many of our League members volunteered as poll workers and others worked for Election Protection with the Lawyer's Committee for Civil Rights Under the Law (also non-partisan). The work for the larger League remains clear - voter protection and education efforts are desperately needed as states require different forms of id, as the dates, times and places for voting change. Our mission to support an informed, participatory democracy is as urgent as ever. The race for 2016 began on November 5, 2014.

Since it is November I also want to add some words of thanks - most especially to you, our members and friends who support us in our work to educate the community on League positions and protect voter rights. Also thanks to our Board - all volunteers, all dedicated to the League and our Akron area. The Board works hard to make sure we have events and programs that advance the role of the League in our community. We have Board positions open and if you are thinking it is time to do more to give back, we would welcome your contributions to our effort. 


## **Holiday Brunch December 6**
