# **President's Message**

Dear Members,

With the primary elections complete and independent candidates certified, the stage is set for the 2015 general election. Much attention is on the city of Akron since for the first time in almost 30 years, Akron will have a new mayor. Another first is that all 13 Akron City Council seats are up for election, so the makeup of the Council could change significantly.

Three State Issues are generating discussion and debate in many venues. Fair Districts for Ohio is a redistricting reform proposal that will appear as Issue 1 on the November 2015 ballot. The Ohio General Assembly came together to approve a bipartisan measure to improve state legislative district lines are drawn. The League of Women Voters of Ohio is a strong supporter of the need for redistricting reform in Ohio and supports adoption of Issue 1.

The LWVO also has recommended a Support position for Issue 2 as it is consistent with League policy that states that the constitution should be a document of general principles.

However, LWVO is Neutral on the aspect of Issue 3 pertaining to marijuana as there is no applicable League position.

The LWVAA Voters Guide will be online within days at lwvaa@lwvaa.org and the printed guide will be distributed by the third week of October. The printed guide will be available in locations including libraries and community centers, at City Hall and other government offices and Acme stores.

We are co-hosting several candidate forums this year including the Akron School Board candidates at the American Red Cross building on October 6, the Akron Mayoral debate on October 13 at the University of Akron's Quaker Square Center, a Richfield forum on October 14 and the Copley Trustee and Copley/Fairlawn School Board on October 15. Even if you haven't done so in the past, please consider voting by mail. You can avoid the polls and have time to refer to the Voters Guide. An absentee ballot request form can be obtained by calling the Board of Elections at 330.643.5200 or you can download a form at www.summitcountyboe.com. If you do vote by mail, your ballot must be postmarked by Election Day, November 3. No matter where or how you vote, be sure to vote!

### **HB 8 Threatens Metro Parks**

The Ohio State House of Representatives has passed HB 8 to the existing regulations for oil and gas drilling.

This bill would give the Ohio Division of Natural Resources the authority to force all subdivisions of the state, including local parks, to join a drilling unit in order to assemble the number of acreage required. HB 8 exempts state parks and state nature preserves but not metro parks, county or city parks. Metro parks, county and city parks could be added to a drilling unit without consent and without any process.

In the past, Summit Metro Parks has a history of these requests, but has successfully been able to deny them. Friends of Metro Parks opposes this legislation because it forces the park district to sell oil, gas, and other minerals in violation of their mission to conserve the natural resources of Summit County for the citizens of Summit County. The bill further threatens parkland from nearby drilling impacts and horizontal drilling under parks and it takes the authority to protect parklands out of the hands of the officials who are elected or appointed through due process. Citizens pay for these lands and direct operations for their use and protection and do not wish to abdicate authority to interests who may threaten the conservation and recreational values of our parks.

HB 8 is directly opposed to the public's interest in

protecting its established parks. The League of Women Voters of the Akron Area is opposed to HB8 based on our Regional Program supporting public land use.

## **Ohio Issues 1, 2, & 3**

The Board of Directors of the League of Women Voters of Ohio (LWVO) announced the following positions on state Issues 1, 2, and 3 for the November 3, 2015 ballot.

#### Issue 1: Support

LWVO's board voted earlier this year to formally endorse the Fair Districts for Ohio redistricting reform proposal that will appear as Issue 1 on the November 2015 ballot. We have been a staunch supporter of the need for redistricting reform in Ohio and have been advocating for such reform for the last forty years. We are pleased that the Ohio General Assembly came together to approve a bipartisan measure to improve how we draw state legislative districts, and we wholeheartedly support its approval by the voters.

**Issue 2:** *Support* Issue 2 because it protects the constitution as a document of general principles.

**Issue 3:** *Oppose* Issue 3 because the constitution should be a document of general principles. *Neutral* on the issue of legalized marijuana.

The League of Women Voters of Ohio has a position, adopted in May 1968, on the Ohio Constitution:

"LWVO believes a constitution should be a clearly stated body of fundamental principles. It should provide for the flexible operation of government and be logically organized and internally consistent."

Based on this position, LWVO opposed the 2009 initiative to write casinos into the Ohio Constitution. However, LWVO is neutral on the aspect of Issue 3 pertaining to marijuana legalization as we have no applicable League position.



## **Akron Mayoral Debate**

The Democratic and Republican Akron mayoral candidates facing off in the November election will participate in a debate to be presented by the Akron Press Club on Tuesday, October 13, 2015, at the University of Akron's Quaker Station.

The debate is co-sponsored by the League of Women Voters of the Akron Area and the University of Akron's Ray C. Bliss Institute of Applied Politics. The two candidates – Summit County Clerk of Courts Dan Horrigan and Akron attorney Eddie Sipplen – have agreed to the debate format. Each candidate will have 90 seconds to answer questions posed by a panel of journalists selected by the Akron Press Club. The other candidates will have 45 seconds each for rebuttal. The order of the questions will be determined by a coin toss. Each candidate will be asked the same number of questions.

Members of the audience are asked to reserve their applause until the end of the debate. No campaigning will be allowed in the debate room, including but not limited to buttons, stickers, T-shirts or other printed material. The Press Club reserves the right to refuse anyone displaying such material admission to the debate room.

**Time**: Doors open at 11 a.m., Tuesday, October 13. The program will begin at 11:55 a.m.

**Place**: Quaker Station, 135 South Broadway (free parking behind the building).

**Cost**: \$20 for Press Club members, \$25 for non-members. \$25 for all reservations made after Thursday, October 8 (members and non-members).
