The primary elections have begun and Ohio's is fast approaching on March 15. This leaves little time to become educated on the candidates at the local, state and national levels. The Summit County Leagues - Akron Area, Hudson and Tallmadge are working together to compile a new online voter guide through Vote411. All candidates certified for the Ohio Primary are invited to participate.

The Local Leagues are inviting candidate participation of those running for state legislative and county offices. Candidates will enter their biographical information and answer questions developed by the three Local Leagues. We are asking candidates to respond immediately so their information will be available well before March 15. The LWV Ohio will gather information on state and federal races, including congressional and US Senate candidates. All candidate information on voters' local elections as well as the state and federal races will be available through the Vote411 website [www.vote411.org](http://www.vote411.org).

**LWVAA Program Planning Wrap-up**

On January 30, thirteen LWVAA members met to review the LWVUS and LWVAA programs and to develop the LWVAA's recommended priorities for 2016-2017. Three groups reviewed the LWVUS public policy positions in the categories of Representative Government, International Relations, Natural Resources, Social Policy. With nearly 50 national policies, the group concurred that LWVAA policies and activities are consistent with the existing national policies.

Several LWVAA policies are recommended for updating of wording and consistency with other regional Local Leagues. There was no recommendation for new LWVAA policy.

Three recommended priorities for LWVAA's 2016-2017 will be voted on at the Annual Meeting:

- Offer voter services and education in areas of Akron that have low rates of voter registration and voting. (New)
- Use our positions to educate and advocate on local issues of water quality, and water consumption and storm water management. (Continue from 2015-2016 program)
- Support efforts to make changes in how apportionment is done, consistent with League positions. (Continue from 2015-2016 program)

Members will have an opportunity to comment or recommend other priorities when the Annual Meeting program is published in the April Voter.
