## Message from the President

The elections are over but many obstacles to register to vote remain. In Ohio, access to voter registration will be significantly increased on January 1 with the implementation of online voter registration.

A new law, SB 63, passed earlier this year implements a system advocated for years by Ohio Secretary of State John Husted.

Benefits will be felt immediately. First, registrations will be more accurate because an applicant's eligibility to vote is checked immediately, before processing the application.

In addition, the online system will save tax dollars, from fifty cents to \$2.54 as estimated by the Pew Charitable Trusts, over the paper registration process.

New processes like online voter registration take time to become widespread and understood. It will increase over the years, thus making it important to begin educating eligible voters immediately.

By beginning now, when the 2020 elections take place the online system will already be widely known and used. Hopefully, increased registration will lead to increased participation in the democratic process.

LWVAA is starting 2017 with two important meetings in January. On 1/7, Voter Services Chair Jackie Darrow will host a committee meeting at her home to review the Primary Election Systems and recommend alternative
