## A Message From the President

Fall is approaching and the work of the League is not slowing down. At the local level, the league is preparing to moderate several school board candidate nights in Akron and surrounding areas. The petition drive to gather enough signatures to place redistricting reform on the 2018 ballot continues. The challenge is to continue the momentum of the first few months when over 100,000 signatures were sent to the state office.

The LWVAA, along with other organized groups provides training for people who want to help gather signatures. It takes about 20-30 minutes and we can arrange training upon request. Contact [Jackie Derrow](#), President-elect and VP of Voter Service, or [me](#) for more details.

At the state level, the LWV Ohio just completed an analysis of the two issues on this year's ballot, listing pros and cons. The five-page guide is available on the [LWVO website](#). At this point, additional analysis is needed to decide whether the League will take a position on one or both issues.

**Issue 1**, Marsy's Law, would alter the state Constitution to expand victims' rights and require that crime victims be notified and consulted on developments in their cases. At this time, Issue 1 has no organized opposition.

**Issue 2** would require state agencies to not pay more for prescription drugs than the federal Department of Veterans Affairs and require state payment of attorney fees and expenses to specific individuals for defense of the law. It also prohibits the state from buying any prescription drug from a drug manufacturer for a price over the lowest price paid for the drug by the United States Department of Veterans Affairs (VA). This issue is complex and it is worth the time to become educated on its provisions.

Also from the state level, the 2016 lawsuit against Ohio Secretary of State John Husted over the process Ohio uses to purge people of the list of registered voters has been appealed by the state and will be heard by the U.S. Supreme Court in October. The U.S. Justice Department has filed a brief in support of the Ohio Secretary of State and has been strongly criticized by LWVUS President Chris Carter:

*"By changing their position in the 2016 Ohio voter purge, the Justice Department is playing politics with our democracy and threatening the fundamental right to vote. We have seen this administration lay the*

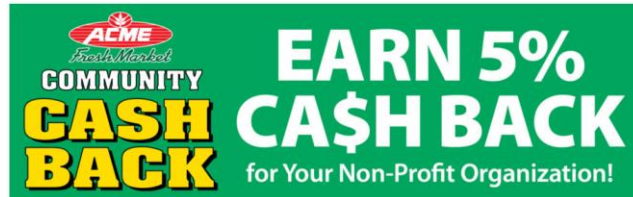

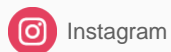
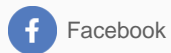
