2019 Annual Meeting Re-cap

We were near capacity at our Annual Meeting June 6 and enjoyed a nice evening with old and new friends, along with conducting a bit of business. LWV Ohio's new Board Chair, Iris Meltzer kicked off the evening by reviewing LWVO's achievements during the year.

The League's accomplishments were capped by the US District Court decision for the plaintiffs in the lawsuit brought by

the ACLU in which LWVO was one of the lead plaintiffs. The decision requires that Ohio re-draw its U.S. Congressional map by June 20. As you're aware, the state appealed the decision to the U.S. Supreme Court and the Court ordered a stay that puts a hold on the remedial plans they are drafting until the court rules on two lawsuits, one from North Carolina alleging extreme Republican gerrymandering and one from Maryland alleging extreme Democratic gerrymandering. The high court's decision will come down this month.

Iris reminded us that the ACLU filed the lawsuit because even though Ohio approved a new process for redistricting in May 2018, those new maps won't go into effect until 2022 and – in case you didn't notice – there's a presidential election in 2020. As well there's great concern that the basis of any new map, the 2020 U.S. Census, is at risk for a significant population undercount, particularly in urban areas like Akron.

As an aside, Summit County has formed a Complete Count Committee to help facilitate full participation in the Census. The Board appointed Liz King to represent LWVAA on the committee and welcomes volunteers interested in supporting the community's efforts.

The Ohio League of Women Voters' convention was held in Columbus on May 10 - 12, 2019. Jackie Darrow, Barbara Hunsicker, and Rosanne Winter from LWVAA attended numerous workshops, plenary sessions, table discussions, the Keynote Lunch, and the Inaugural Gala!

The workshops we attended centered on Advocacy, Lobbying, the For the People Act, Voter Registration, Voting Rights, Diversity, and Equity and Inclusion. Plenary sessions dealt with the business of the League including presentations of budget, development plan, 2019-2020 program, action resolutions, and election of new officers.



The luncheon keynote address was delivered jointly by Dr. Ric Sheffield and Dr. Carol Lasser and outlined the history of voting in Ohio for women and people of color. The keynote speaker at the Gala, Rosie Rios, 43rd Treasurer of the United States, shared her thoughts about our society's perceptions about women in leadership and discussed actions she has taken to strengthen the perception of women as equal participants in all societal functions – including governing.

Legislative Update

Contact your Legislators

Watch for LWVO ACTION ALERTS that request action on pending state and federal legislation. The Alerts provide information on the issue, talking points and easy ways to contact your state representatives. Below is a summary of recent alerts.

CENSUS FUNDING

ASK your state senator to help ensure we count every Buckeye by supporting the funding of Census work.

House Bill 6. The "Clean" Energy bill passed out of the house and is now in the senate. The bill bails out FirstEnergy Solutions' aging nuclear plants, which arguably represent 90% of Ohio's carbon-free energy, but in the last re-write, it also bails out two FirstEnergy coal plants while eliminating the current mandates for renewable energy.

ASK your state senator to **VOTE NO** on HB 6. Ohio needs to encourage clean energy. This bill needs a significant re-write to achieve that.

HB154. The Ohio School Transformation Plan would end the state take over of schools and instead require the creation of community learning centers for schools in low performing districts. It is a constructive solution to the failed state takeover law that is now at risk!

HB 154 was overwhelmingly approved by the House. **Now, some senators want to replace the old plan with a new state intervention that includes funding for consultants but not children.** The Ohio School Transformation Plan, like the failed policy it would replace:

- Includes loss of local control.
- Uses standardized tests to define school quality, a misuse of standardized tests that produces a narrow definition of quality.

- Discriminates against poor children.
- Assumes low test performance is a governance problem.
- Neither increases the state investment in public schools nor levels the playing field - conditions needed before accountability can be fair.

ASK your state senator to oppose a plan that perpetuates the misuse of standardized tests, distrusts local leaders, and punishes poor children.

Federal Legislation


U.S. House Resolution 1, THE FOR THE PEOPLE ACT. The provisions in the Act will modernize our election system, reform redistricting, restore the Voting Rights Act, and improve transparency in our elections. The For the People Act will improve American elections by making our election system more free, fair, and accessible to all eligible Americans.

ASK U.S. Senator Portman, (202) 224-3353, to call for a hearing on the For the People Act (S. 949). [Note: Those of us who attended the Annual Meeting completed postcards with this request.]
